- Host Professional:** Mike McCabe, Director of Golf (972) 355-4800.
- Eligibility:** Open to all eligible NTPGA Members and Apprentices, with the exception of A-3 Members.
- Format:** 18-holes at individual stroke play.
- Divisions:** Two separate divisions will comprise the competition. Professionals will be competing for a purse based upon their PGA classification. All class-A members (except A-8) will compete in the Open Division. All A-8 members and all apprentice classifications will compete in the Assistants' Division.
- Purse:** \$3,600.00 estimated total purse (based on a field of 72 players). Professionals will be competing for the purse allocated to their division. A professional may not win money or compete in both divisions.
- Entry Fee:** **\$80.00 per player.** This includes cart/range fees and a 20% off coupon for the grill.
- Entry Deadline:** **Thursday, January 28 at 5:00 p.m. CST.** The first 72 entries will be accepted into the field. Entry forms shall be returned to the Northern Texas PGA via mail, facsimile, overnight carrier or in person prior to the entry deadline. Online entries will be accepted at www.ntpga.com. Late entries will be accepted on a space available basis with a \$25.00 late fee.
- Starting Time:** **Play will commence with a 9:00 a.m. shotgun start.** Groupings will be available by calling Bridlewood Golf Club, the Northern Texas PGA or by checking www.ntpga.com after 3:00 p.m. on Friday, January 29.
- Practice Rounds:** Please contact Bridlewood Golf Club to schedule a practice round starting time.
- Assistants' Points:** Points will be awarded toward making the 2010 James P. Jordan Cup Team to the top twenty Assistant Golf Professionals and all apprentice classifications.
